

The courses are offered with the highest standard of course qualification in collaboration with Confederation of Tourism and Hospitality (CTH) Awards, UK. CTH is an awarding body recognised and regulated by Ofqual, the official regulators for general and vocational qualifications in England, UK. Ofqual qualification is an excellent start to a promising career with truly global opportunities. UEI students on the basis of their qualifications will be provided with the credit transfer and be granted exemptions in certain mandatory units. Students will also need to have at least IELTS 5.5 level English or equivalent and demonstrable academic study skills to qualify for the programme.

The course aims to provide students with an understanding of the managerial decision making and leadership aspects of the industry. In addition it is also designed to develop independent research and study skills required when working at a senior managerial level in the industry. 2. All applications are reviewed by the International University Admission Team or Committee and acceptance by the University will be on the basis of seat availability and Candidates meeting out their admission criteria
3. Candidates are evaluated based on the candidate's academic performance through school, colleges and their involvement in extra-curricular activities followed by their performance in course assessment
4. Candidates should ensure that they have detailed information regarding their programme specific tuition fees for a complete understanding of the financial aspects related to their chosen course
5. Language proficiency through recognised tests like TOEFL, IELTS, or equivalent will be required to demonstrate English Proficiency
6. Candidates may be invited for an interview, in person or virtually, to assess suitability for their chosen programme
7. Tuition fees and other applicable fees are to be paid to the respective University where the Candidates pursue their studies at that year
8. Course Credits so granted or obtained are accepted or transferred at the sole discretion of the relevant University offering the diploma or degree. The Candidates should ensure and enquire further regarding the suitability of their chosen Country & Course for their academic, professional requirements and post study work prospects before enrolling

Important Instructions

1. The Candidate must read the prospectus carefully before filling the application form. Application form should be filled in by the candidate's own hand writing in English only.

Terms and Conditions for Placement

After the student successfully completes the programme, there will be 3 interview opportunities provided to them domestically across the hospitality sector, in case they are not able to secure the International Placement through the International University they have enrolled for their Degree courses. UEI Global Education will ensure to provide these interview opportunities within 6 months of the student completing the programme successfully and returning back to India with its International Certification and Degree. It is in the best interest of the student to prepare suitably during and after the programme completion to appear adequately for the national & international interviews.

Successful completion includes the following

- The student should have acquired the requisite academic grades - Min. 60% in the assessments & 75% attendance in their academic tenure.
- The student should have had NO disciplinary actions suggested/ taken against him/her during his/ her academic stay at UEI Global. The student should have completed all training/visits as part of the training to the designated places allocated suitably by UEI Global. The student should have had NO complaints against him/ her regarding the fee dues.
- Default of even ONE installment shall disqualify the student for any educational opportunity and UEI Global shall have NO obligation towards this student for placement.

Frequently Asked Questions

What are the academic eligibility requirements?

The students should have good academic score in the first two years of their study. Minimum 60% with no backlogs and re-appears

Is English Proficiency test required?

English Proficiency test would be subjective to the University & Country you are applying to. Generally, The required score is 5.5 ~ 6.5 bands, though in some module the university may require not less than 6. In certain cases, partner Universities waive off the IELTS requirement depending upon their academic qualifications and language proficiency considering their course delivery in English during their scholastic years. It is entirely a subjective exemption.

Is the SAT required for admission to foreign university for the undergraduate courses?

SAT is not required for the admission in the undergraduate courses at the partner foreign university when a student is taking course credit transfer through UEI Global.

Are there any charges involved in the International University Lateral Entry for Programmes so enlisted by UEI Global ?

The student has to pay the tuition fee of the overseas host university along with the visa application charges, travel expenses and the living expenses while studying at overseas host university.

When and how can I apply for an education loan?

You can apply for an education loan once you have a conditional offer letter from the partner university. The conditional offer letter is a document that you can provide as a supporting document to the bank while applying for Education loan.

Would University be applying for the visa on my behalf?

You would directly apply for the visa once you have procured the necessary documents. The UEI Global team would only help in procuring relevant documents pertaining to UEI Global to apply for visa.

Can I do a part time job while studying at Foreign University?

It will depend upon the rules and regulations of the country where you are going. Generally, you would be allowed to work on a student visa as per the law of the land. In most situations, the student can work 20 hours per week during the duration of their study.
